Terms & Conditions

The Amigo Gold card is personal, non-transferable and nominative. It will be required on every occasion in order to enjoy the special benefits that correspond to it, and for this purpose it will be activated by our system once the payment of the fee, if requested, is received. Annual membership is applicable from January. Expiration corresponds with the calendar year. Maximum 100 rounds per year. It is required at all times the utmost courtesy to other Platinum Friends and users of the Club facilities as well as to employees, and compliance with the dress code established by the Club.

The Club reserves the right to cancel the Amigo Gold card, returning the proportional part of the period not consumed. For reasons of maintenance of the course, holding tournaments, or for the use of specific groups that require the exclusivity of the course, the Club reserves the right to close some days of the year without giving reason for partial or total refund of the amount paid. Unless otherwise provided by law, the amount paid will not be refunded in full nor in part, in the event that for any reason, foreseeable or not, but in any case beyond the control of RIO REAL GOLF HOTEL SL, cannot be provided all or part of the golf services and / or activities or services related to it.

Rio Real Golf Hotel S.L. is not responsible for the loss, damage or misplacement of any personal belongings deposited in its facilities. Users and visitors are solely responsible for securing and guarding their personal belongings during their stay.

Tee Times - Online booking system

Tee times may be booked online a maximum of 72 hours in advance.

As a Amigo Gold Card holder, you will receive a username and password to book your tee times online in the private section of our website.

The Club Management reserves the right to extend this privilege to groups, but this is not the responsibility of the Caddy Master in any case.

The Starter and Marshall may add other players to Amigo Gold rounds.

For course maintenance, tournaments or occasional groups that require the exclusive use of the course, the Club reserves the right to close on some days of the year.

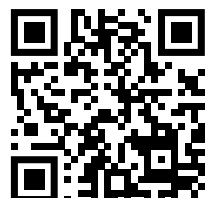
Cancellations

Cancellation period: *the established period for cancellations is 24 hours before the date of the game.*

Penalty: *reservations will not be accepted within 30 calendar days if 4 reservations are reiterated without justified cancellation in due time and form. The Club reserves the right to not admit any more reservations if, repeatedly, the holder:*

- a) Makes a reservation and does not show up*
- b) Books for a certain number of members or guests and a fewer number of players show up.*
- c) Makes a reservation and does not cancel within the established cancellation period.*
- d) Does not arrive at the tee off, at least 10 minutes before the reserved time.*
- e) Does not accept the instructions of the starter or marshal when assigning additional players to their round.*
